THIS AGREEMENT is made and entered into between East Arkansas Broadcasters of Jonesboro, LLC Special Events Department with offices at 407 West Parker Road in Jonesboro, Arkansas 72404 (870-934-5000), hereinafter called EAB, and

There shall be one (1) complete contract for each event/vendor.

WHEREAS, EAB is a company with the exclusive right to develop and operate all East Arkansas Broadcasting Special Events, to be held at various locations and times throughout the year, and

WHEREAS, VENDOR is skilled and experience in the sale of goods and services to large crowds and has adequate equipment and facilities for said purposes, there the parties agree as follows:

**VENDOR AGREES TO:**

- (1) Obtain all Jonesboro and Craighead County permits and licenses and comply with all applicable regulations of said permits
- (2) Position and operate stand in location and during the times specified by EAB: 10 AM-5 PM on Saturday, October 20
- (3) Pay EAB a fee of \$60.00 to participate in the event, which will be remitted upon return of this contract
- (4) Supply extension cords and other necessary equipment to utilize venue electricity if needed
- (5) Pay cost for labor and materials required for additional power needs or services not available at the venue
- (6) Sell products of the highest quality and provide sufficient supplies and products to continuously provide for sale to the public. Sell only those items and portions at the prices as agreed upon and as listed on the application. Selling items at a price different from the price specified in this AGREEMENT will result in closure, eviction from the event, and non-inclusion for consideration in future events.
- (7) Neither sell, give away, nor consume alcoholic beverages or illegal drugs while on event site
- (8) Display prepared and installed signage indicating prices
- (9) Comply with EAB rules and regulations regarding load-in/load-out, restocking hours, parking and traffic, etc. Said information to be provided by EAB
- (10) To indemnify and hold EAB and the event venue harmless for any and all claim of third party, "claims" including, but not limited to: all costs, liabilities, judgments, expenses, sales taxes, damages, and

any reasonable attorney's fees proximately caused by (a) breach of any provision of this agreement, or (b) any intentional act, negligence, or omission to act of vendor, their employees, or agents

**EAB AGREES TO:**

- (1) Provide vendor with space referred to above, location to be determined by EAB
- (2) Provide access to garbage disposal site and/or garbage receptacles during the event

This agreement shall be binding upon the parties hereto, their heirs, and successors. However, this agreement is not assignable by either party.

The Parties shall be, and act as, independent contractors, and under on circumstances shall this agreement be construed as one of Agency, Partnership, Joint Venture, or Employment among the parties. The parties shall be solely responsible for the conduct of their respective employees and agents in connection with the performance of their obligation hereunder.

This agreement contains the entire agreement between the parties. No other representations have been made and no modification shall be made by either party, without the written consent of both parties.
